- 1 The gun violence stat is totally bogus and **trumped up** number .
- 2 The government was pursuing **trumped up** legal charges against him.
- 3 Strike supporters are arrested on **trumped up** charges.
- 4 All these **trump up** figures are from your wild imagination .
- 5 He says the charges have been **trumped up** " .
- 6 Ethel's brother says he **trumped up** evidence.
- 7 He says they were **trumped up** to damage him.
- 8 Others speculated that the Salzburg incident was **trumped up** by critics.
- 9 Behind the scenes Israel is **trumping up** the case for war .
- 10 Tatchell observes that **trumped up** charges are routine in Iran.
- 11 And Egypt's rulers are prosecuting NGO leaders on **trumped up** charges.
- 12 Tax-evasion charges were **trumped up** against the newspaper and its director arrested.
- 13 Instead of facing **trumped up** charges, Boulanger fled to Belgium.
- 14 Miami police harass, and arrest the sit-ins on **trumped up** charges.
- 15 J.R. demonstrates how he could use his influence to **trump up** rape charges.
- 16 There is no trickery here, no artificial hazards or **trumped up** mounds.
- 17 Brother Henry Okah was jailed on flimsy , **trumped up** circumstantial evidences.
- 18 Davis lawyers wanted an expedient trial to prove her innocence on **trumped up** charges.
- 19 Anwar was arrested and banned from politics on what are considered **trumped up** charges.
- 20 MDC-T has since dismissed the charges against the activists as " **trumped up** " .
- 21 Extradition on **trumped up** charges is difficult in England but easy in Sweden.
- 22 I don't care about all the **trumped up** stuff in the media.
- 23 Arresting people on **trumped up** charges is the ICTY's only triumph.
- 24 But Esaw Garner and other family members said it was a **trumped up** claim.
- 25 These **trumped up** prosecutions would stop if everyone exercised their right to a TRIAL !
- 26 The charges have been **trumped up** to satisfy the political aspirations of the British empire.
- 27 At least nine journalists and four Facebook activists are in jail on various **trumped up** charges.
- 28 Ai maintains the charges were **trumped up** in retaliation for his criticism of the government .
- 29 They want to **trump up** a reason to fire you for violating a company rule.
- 30 According to HRF Llori was imprisoned on **trumped up** terrorism charges by the government.
- 31 He was imprisoned on **trumped up** charges shortly after Marcos's 1972 declaration of martial law.
- 32 Our brother, Henry Okah is innocent of all those **trumped up** charges against him.
- 33 The question is what is the cause of the arrest not whether charges are **trumped up** .
- 34 Note the attack of male nature and **trumped up** " male ego" for no reason.
- 35 Either a **trumped up** smear , or by a straight up Harvey Oswald style plot.
- 36 He had Anne Boleyn executed on a charge, believed **trumped up** , of infidelity.
- 37 For this he is arrested on **trumped up** charges of theft and is sent to Montreal.
- 38 First , watch the one minute statement that is the center of this **trumped up** charge.
- 39 This crisis led to the **trumped up** charges leading to the trial and imprisonment of Awolowo .
- 40 She tries to flee the country after being dragged into trial on some **trumped up** obscenity charges.
